NOW THIS TRUST DEED OF PUBLIC CHARITABLE TRUST WITNESSETH AS UNDER:
The main features and shape of the present establishing Trust shall be as under :-

NAME OF THE TRUST: The name of the trust shall be GRIHASTHA UNIVERSAL EDUCATION & SOCIAL TRUST (GUEST).

HEAD OFFICE: The head office of the said trust shall be at C/o S.P. Yadav, 672, Ushma Urja Apartment, Sector-62, Noida (UP) - 201301.

TRUST DEED: The amount contributed by the Chairman/Founder/Settler & Trustees shall stand possessed the same upon the trust and also the trustees may from time to time receive for augmenting the trust funds as donations, gifts, interests, loans to capital deposit, etc. for the general public and general purpose of the trust, fund of the trust arising from the subscriptions, donations, grants, or otherwise from any sources and also of any investment etc. representing the same, (herein after called 'THE TRUSTEES'). Furthermore, the net income from the said trust fund, to apply both the capital and income of the said trust fund for the purpose and betterment of the aims and objects only of the said trust.
